Discussion: Key Questions (Flaws)?

- Why is there an Area Map? Is ODP now the only department that still uses a geographic area map to distinguish service rates in different regions of the Commonwealth?
- Why use Workforce Development Area data? BLS data is readily available for each county individually, and ODP assigns a rate for each county to determine area designation.
- Who determined the job classifications and weightings? It is not clear who recommended these classifications as representative of community services and how the weighting was determined.
- Why do rates of pay across an ID joinder need to be aligned? This introduces an added layer of complexity that skews the BLS data and results in further area assignment changes.
