AUDIENCE:

All Interested Stakeholders

PURPOSE:

To announce the June 3rd News Alerts for providers to assist in managing and developing infection control strategies, including COVID-19 and Monkeypox.

DISCUSSION:

A News Alert from the Infection Prevention Specialist Partnership with Health Care Quality Units has been released with information regarding performing Covid testing, treatment, and up to date COVID-19 vaccine booster dose recommendations. A separate informational News Alert regarding Monkeypox. is also attached.

The Office of Developmental Programs (ODP) has received funding through a Pennsylvania Department of Health (DOH) grant from the U.S. Centers for Disease Control and Prevention (CDC) appropriation under the 2019 Epidemiology and Laboratory Capacity for Prevention and Control of Emerging Infectious Diseases (ELC) - Enhanced Detection Expansion (EDE) Grant.

This grant funding is being used to build capacity and provide additional support for infection prevention and control through the Health Care Quality Units (HCQUs) in partnership with a team of infection prevention specialists from Infectious Disease (ID) Connect. This project will run through June 2023.

The goals of the program include a focus on:

1. Infection Prevention, Preparedness and Response
2. Education and Training

ID Connect will:

- provide enhanced technical support and guidance to ODP’s providers and other stakeholders, coordinated through the HCQUs staff in the areas of infection prevention and response, including but not limited to COVID-19, influenza, and norovirus infections.
- build capacity within the HCQUs by providing ongoing education and guidance to HCQU staff.
- assist providers who are in need of COVID-19 outbreak support and guidance. Support will be coordinated by the HCQUs and if needed may request additional information to submit the information to ID Connect for further input.
- provide regular townhall meetings for ODP stakeholders on topics related to infection prevention and control.
- distribute updates and alerts to stakeholders regarding infection prevention and control.
