

Clarification of Deaf Services Requirements

ODP Announcement 22-097

AUDIENCE:

Individuals and Families, Administrative Entities, Supports Coordination Organizations and Providers of Consolidated, Community Living, or Person/Family Directed Support (P/FDS) Waiver Services or Base-Funded Services

PURPOSE:

This announcement is to clarify Supports Coordinator and Provider responsibilities when supporting d/Deaf, hard of hearing, and DeafBlind individuals.

DISCUSSION:

There is some confusion regarding deaf services within ODP. First, to clarify who is a Harry M class member and who is not:

While the settlement has now ended, ODP's commitment to effectively supporting d/Deaf, hard of hearing, and DeafBlind individuals continues and requirements are still in effect.

Continued requirements for teams of Harry M class members:

- Communication Assessments and Reassessments
 - ODP's commitment to providing assessments and reassessments to class members continues. Individuals whose assessment recommended a reassessment can expect to receive a reassessment through Temple Institute on Disabilities.
 - These can only be declined by the class member. Supports Coordinators and providers need to be responsive and accommodating to the assessor when the assessor makes contact to schedule.
 - The implementation and continuation of the recommendations is critical for the improvement of the individual's communication and their overall quality of life.
 - Not providing the needed communication support as recommended is considered a rights violation. As defined in ODP Bulletin 00-21-02, "The failure to support an individual to communicate at all times. This includes a failure to obtain needed communication evaluations, assistive devices or services; provide communication support; or maintain communication devices in working order."
- Supports Coordinators, Providers, Investigators, and Monitors must complete
 the training as required in ODP Announcement 119-17 on MyODP.
- Residential Habilitation vacancy management process for any vacancies that become available in a home where a Harry M. class member resides.

Requirements for teams of d/Deaf individuals who are not Harry M class members:

- When a D/deaf individual is enrolled in the Consolidated, Community Living, or P/FDS waiver, the Supports Coordinator is to check the "Harry M. Litigation" checkbox in the demographics screen in HCSIS. This does not identify them as a class member since the settlement is closed. Within 30 days of the individual being enrolled in an applicable waiver, the Supports Coordinator should contact the Deaf Services Coordinator at RA-ODPDeafServices@pa.gov for a consultation. This consultation will allow the Deaf Services Coordinator to recommend specific trainings and resources, and a communication assessment by a Speech and Language Pathologist, if applicable.
- Supports Coordinators, Providers, Investigators, and Monitors must complete the training as required in ODP Announcement 119-17 on MyODP.
- If the needed communication support is not provided, it is considered a violation of the individual's rights. As defined in ODP Bulletin 00-21-02, a rights violation is, "The failure to support an individual to communicate at all times. This includes a failure to obtain needed communication evaluations, assistive devices or services; provide communication support; or maintain communication devices in working order."
