#### DISCUSSION:

The Office of Developmental Programs (ODP) strives to ensure effective use of statewide residential resources.

For purposes of reporting residential vacancies, a "residential vacancy" is any change in a Licensed 6400 or Licensed 6500 settings that results in the occupancy of the home being less than the setting's approved program capacity (excluding individuals who are on medical or therapeutic leave). **Residential Vacancy Tool**
