Dues Policy Statement
Fiscal Year 2023-24**

Policy Statement:

Dues are determined annually for all membership categories and approved by the Board of Directors in accordance with the bylaws of The Provider Alliance (TPA). Dues policy is communicated to membership to ensure consistency of application and transparency in the establishment of dues and processes related to billing, payment processing, and collection.

The following dues, definitions, and practices apply to member dues for fiscal year 2023-24:

1. Annual Dues for Provider Members

- a. Organizations with ID/A annual operating revenues of \$50M or more: **Annual dues are \$7,999 per year.** Includes full membership listing and benefits for The Provider Alliance and the Center for Healthcare Solutions and includes full membership for one additional affiliated organization or subsidiary in The Provider Alliance. Additional affiliated organizations or subsidiaries may be added and granted full membership privileges for \$1,000 each.
- b. Organizations with ID/A annual operating revenues of at least \$25M but less than \$50M: **Annual dues are \$6,999 per year.**
- c. Organizations with ID/A annual operating revenues of at least \$10M but less than \$25M: **Annual dues are \$5,999 per year.**
- d. Organizations with ID/A annual operating revenues of at least \$5M but less than \$10M: Annual dues are **\$4,999 per year.**
- e. Organizations with ID/A annual operating revenues of at least \$2M but less than \$5M: Annual dues are **\$3,999 per year.**
- f. Organizations with ID/A annual operating revenues of less than \$2M: Annual dues are **\$999 per year.**
- g. Submission of a completed Revenue Verification Statement may be required.

2. Annual Dues for Associate Members

- a. Annual dues are **\$1,999.**
- b. Associate Members include Administrative Entities, Supports Coordination Organizations, Health Care Quality Units, and local vendors and businesses offering good and/or services to TPA members.
- c. Affiliates of qualified providers may not join exclusively as Associate Members.

- i. If the Associate Member is an affiliate of a Provider Member, dues will be discounted by \$999 resulting in annual dues for the **Provider-Affiliated Associate Member of \$1,000.**
 - ii. **TPA members at dues level 1a or 1b may add one affiliate at no additional cost.** Additional affiliates may be added for \$1,000 for each additional affiliate.
3. Subscribers
 - a. In an effort to promote TPA services and benefits certain non-members may be added to TPA mailing lists as Subscribers. Subscribers will not have access to live or virtual TPA meetings or events unless explicitly invited by TPA.
4. Payment Methods
 - a. All member payments are due by July 31, 2023 or 30 days after invoice, whichever is later. Delinquent payments are subject to interest charges and late fees.
 - b. Installment payments are permitted if authorized through TPA automated monthly subscription enrollment process using a bank account or credit card.
 - i. A service charge will be added for installment payments.
 - ii. Members or Subscribers paying through monthly installments who cancel membership during the year may be charged a 90-day termination fee or be charged for the remainder of the membership year.
 - iii. Members or Subscribers paying through monthly installments may opt out of membership each year between June 1 and June 30, prior to the upcoming membership year, with no additional charges.
5. Credit card or other electronic installment payment methods may incorporate a service charge of up to 5%.
6. The application and payment of available discounts is the responsibility of the member. TPA is not responsible for unclaimed discounts or inaccurately reported ID/A revenue used to determine dues reflected in this policy.
